

ORDINANCE #2016-2017

WHEREAS, the State of Illinois has enacted “An Act regulating wages of laborers, mechanics and other workers employed in any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, codified as amended, 820 ILCS 130/1 et seq. (1993), formerly Ill. Rev. Stat., Ch. 48, par. 39s-1 et seq. and

WHEREAS, the aforesaid Act requires that the Calhoun Community Unit School District #40 investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Calhoun Community Unit School District #40 employed in performing construction of public works, for said Calhoun Community Unit School District #40.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF THE CALHOUN COMMUNITY UNIT SCHOOL DISTRICT #40:

SECTION 1: To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Calhoun Community Unit School District #40 is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Calhoun County area as determined by the Department of Labor of the State of Illinois as of June 2007, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the public works construction undertaken by the Calhoun Community Unit School District #40. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Calhoun Community Unit School District #40 to the extent required by the aforesaid Act.

SECTION 3: The Clerk of the Calhoun Community Unit School District #40 shall publicly post or keep available for inspection by any interested party in the main office of the Calhoun Community Unit School District #40 this determination or any revisions of such prevailing rate of wage. A copy of this determination or any revisions of such prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Clerk of the Calhoun Community Unit School District #40 shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Clerk of the Calhoun Community Unit School District #40 shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION 6: The Clerk of the Calhoun Community Unit School District #40 shall cause to be published in a newspaper of general circulation within the area notice that the determination is effective and that this is the determination of this public body.
